WITHDRAWING LAND FROM THE OPERATION OF GOVERNOR'S EXECUTIVE ORDER NO. 4403 DATED FEBRUARY 20, 2012

WHEREAS, by Governor's Executive Order No. 4403 dated February 20, 2012, certain land situate at Upper Pouhala, Waikele, Ewa, Oahu, Hawaii was set aside for Agriculture Purposes; and

WHEREAS, the Board of Land and Natural Resources at its meeting of July 11, 2014, approved the withdrawal of a portion of land from Executive Order No. 4403 dated February 20, 2012.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that the following described land and improvements, identified as "Withdrawal Portion of Agriculture Purposes Site, Governor's Executive Order 4403," situate at Upper Pouhala, Waikele, Ewa, Oahu, Hawaii, containing a gross area of 96.801 acres, and a net area of 91.216 acres, after exclusions, and subject to any valid encumbrances, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated as C.S.F. No. 25,411 and dated December 11, 2014, is hereby withdrawn from the Operation of Governor's Executive Order No. 4403 dated February 20, 2012.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.


