WITHDRAWING LAND FROM THE OPERATION OF GOVERNOR'S EXECUTIVE ORDER NO. 4170 DATED AUGUST 14, 2006

WHEREAS, by Governor's Executive Order No. 4170 dated August 14, 2006, certain lands situate at Mokauea and Kaholaloa, Sand Island, Honolulu, Oahu, Hawaii were set aside for maritime purposes; and

WHEREAS, the Board of Land and Natural Resources at its meeting of September 26, 2014, approved the withdrawal of portions of land from Executive Order No. 4170 dated August 14, 2006.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that the following described land, identified as "Withdrawal Portions of Maritime Purposes Site, Parcel 1 and Parcels 3 to 6, inclusive, Governor's Executive Order 4170," situate at Mokauea and Kaholaloa, Sand Island, Honolulu, Oahu, Hawaii, consisting of:

Parcel 1 containing an area of 6.702 acres, Parcel 3 containing an area of 7.949 acres, Parcel 4 containing an area of 6.000 acres, Parcel 5 containing an area of 1.535 acres, and Parcel 6 containing an area of 1.218 acres,

more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated as C.S.F. No. 25,419 and dated March 6, 2015, is hereby withdrawn from the Operation of Governor's Executive Order No. 4170 dated August 14, 2006.
