




171-11, Hawaii Revised Statutes, as amended, do hereby order that the following described land, identified as "Withdrawal Portion of County Quarry and Borrow Pit Site, Governor's Executive Order 2188," situate at Waiakea, South Hilo, Island of Hawaii, Hawaii, containing an area of 5.340 acres, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated as C.S.F. No. 25,481 and dated December 24, 2015, is hereby withdrawn from the Operation of Governor's Executive Order No. 2188 dated April 6, 1965.



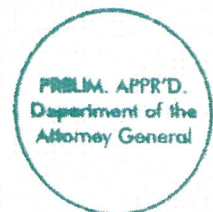

Being a portion of the Government (Crown) Land of Waiakea.

Beginning at the west corner of this parcel of land, and at the southeast corner of the intersection of two Proposed 50-Foot Roads, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 9662.44 feet South and 18,451.35 feet East, thence running by azimuths measured clockwise from True South:-

1. 251° 00' 519.25 feet along south side of Proposed 50-Foot Road;
2. 341° 00' 448.00 feet along the remainder of County Quarry and Borrow Pit Site, Governor's Executive Order 2188;
3. 71° 00' 519.25 feet along the remainder of County Quarry and Borrow Pit Site, Governor's Executive Order 2188;

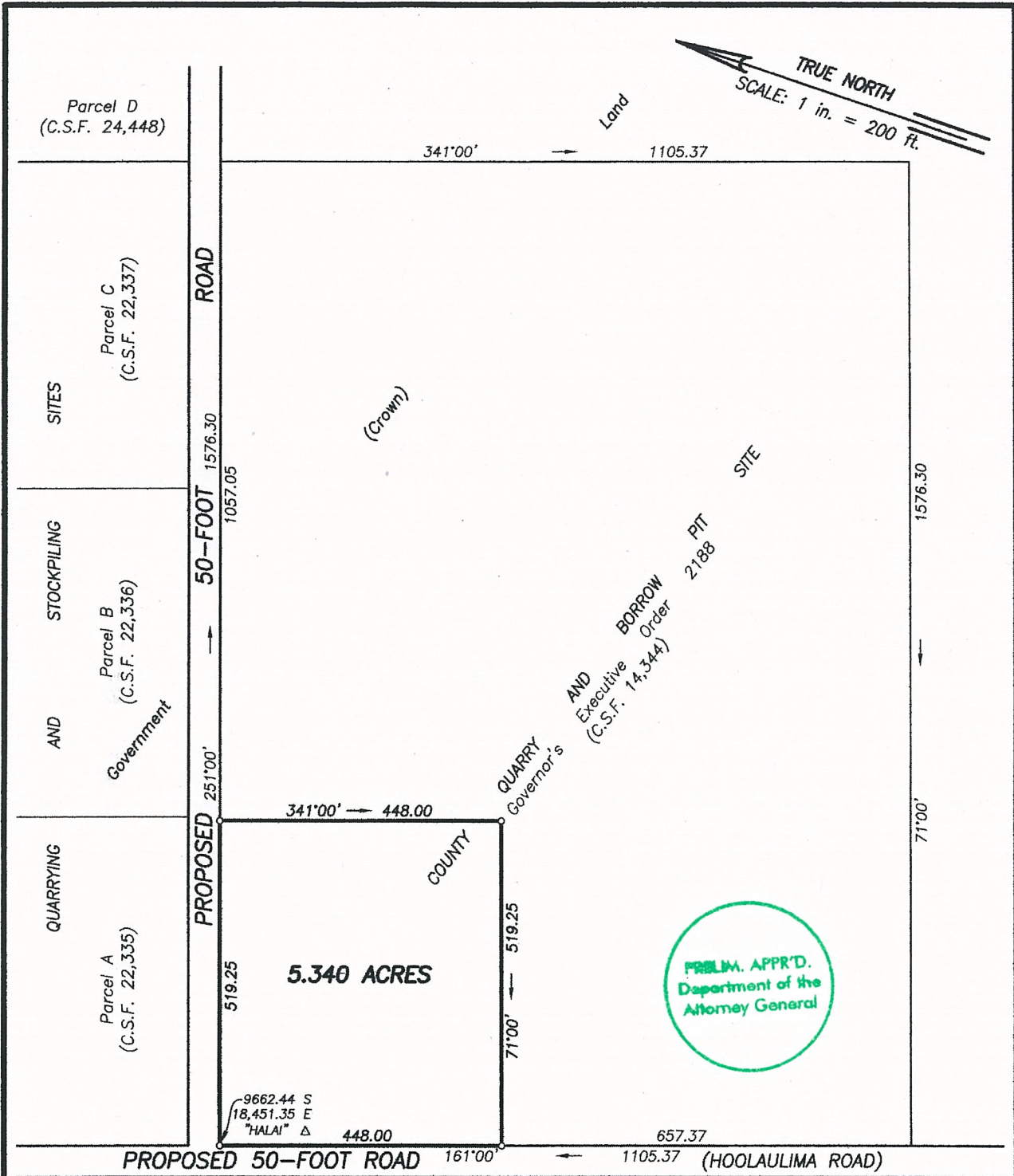
