#### SETTING ASIDE LAND FOR PUBLIC PURPOSES

BY THIS EXECUTIVE ORDER, I, the undersigned, Governor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, as amended, and every other authority me hereunto enabling, do hereby order that the public land and improvements hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR PARKING AND RELATED USES IN SUPPORT OF NON-VEHICULAR, RECREATIONAL TRAIL, to be under the control and management of the County of Hawaii, being that parcel of land situate at Lalamilo, South Kohala, Island of Hawaii, Hawaii, and identified as "Trailhead, Parking Area and Related Purposes Site," containing an area of 16.688 acres, more or less, SUBJECT, HOWEVER, to a Perpetual Non-Exclusive Easement for Electric




Transmission Line (40.00 feet wide), and RESERVING to the State of Hawaii, its successors and assigns the free flowage of water, all riparian rights and other rights in and to Waikoloa Stream, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 25,484 and dated December 31, 2015.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the County of Hawaii shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

## SUBJECT, FURTHER, to:

- 1. The County of Hawaii's plans for development shall be subject to approval by the Chairperson of the Board of Land and Natural Resources, and any excess lands of sufficient economical use shall be subdivided, withdrawn and returned to the State of Hawaii.
- 2. The property shall be subject to any and all existing easements.
- 3. Disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.
