

to the State of Hawaii, situate at Honouliuli, Ewa, Oahu, Hawaii, and identified as "Public School Purposes Site," more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated C.S.F. No. 25,350 and dated December 13, 2013, and as shown on Land Court Map 1410.

Said lot is subject to:

1. Declaration dated February 3, 1989, filed in Land Court Document No. 1611704.

2. Declaration of Covenants, Conditions, and Restrictions on Use (Makai Lands) dated April 29, 1997, filed in Land Court Document No. 2378007.

3. Assignment of Rights (Golden Triangle) dated March 1, 2006, filed as Land Court Document No. 3398318.

4. Certificate and Authorization dated December 4, 2000, filed in Land Court Document No. 2682016.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the State of Hawaii, Department of Education shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

SUBJECT, FURTHER, to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.

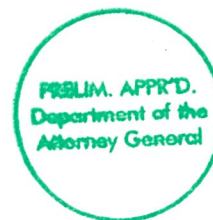

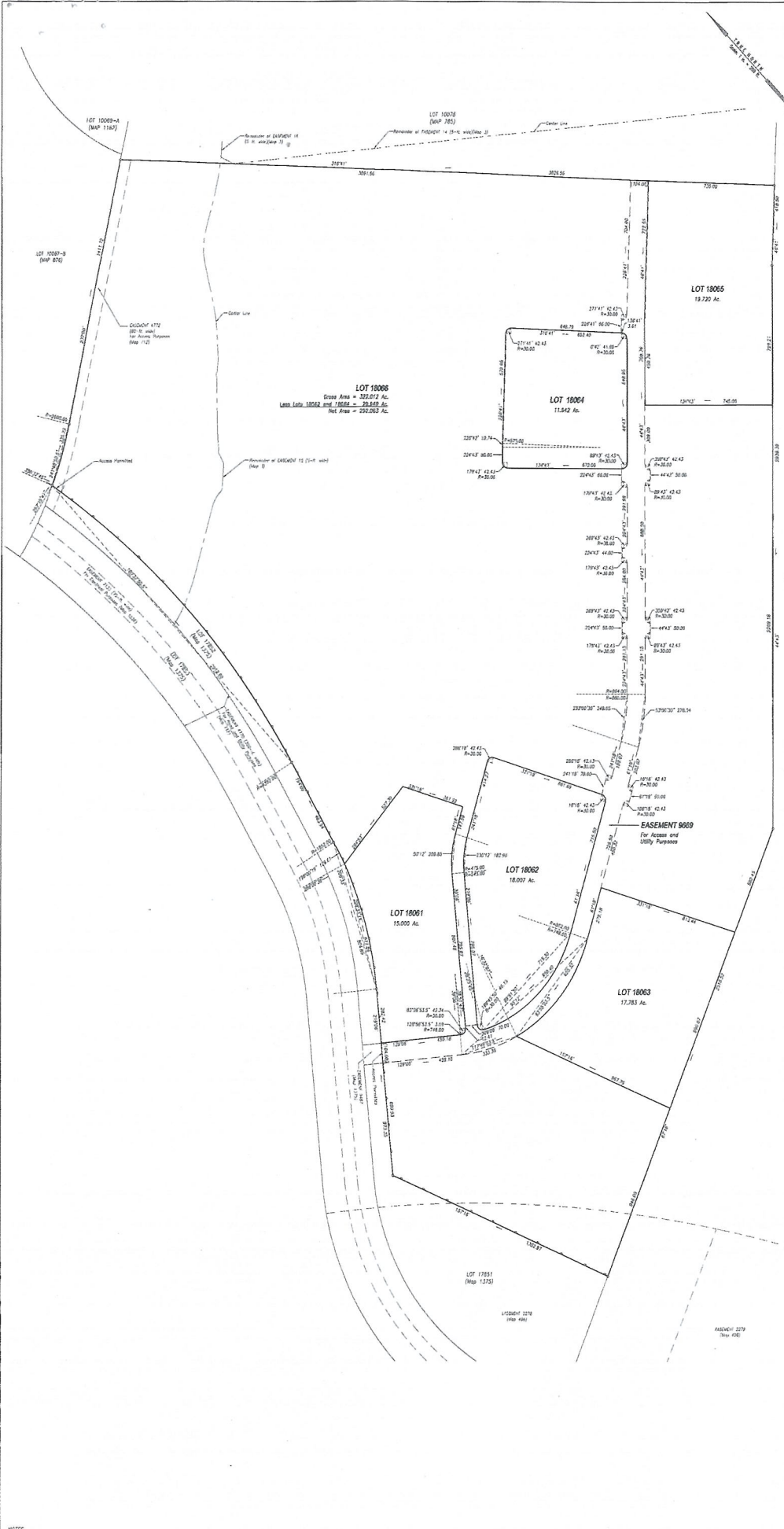
