EXECUTIVE ORDER NO. 4525

WITHDRAWING LAND FROM THE OPERATION OF PROCLAMATION DATED JUNE 12, 1907

WHEREAS, by Proclamation dated June 12, 1907, certain lands and improvements situate at Koolau, Hana, Maui, Hawaii were set aside for the Koolau and the Hana Forest Reserves; and

WHEREAS, the Board of Land and Natural Resources at its meeting of February 13, 2015, approved the withdrawal of a portion of land from Proclamation dated June 12, 1907.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 183-11, Hawaii Revised Statutes, as amended, do hereby order that



the following described lands and improvements, identified as "Withdrawal Portion of Hana Forest Reserve, Governor's Proclamation dated June 12, 1907," situate at Haneoo and Aleamai, Hana, Maui, Hawaii, containing an area of 441 acres, more or less, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated as C.S.F. No. 25,553 and dated October 14, 2016, are hereby withdrawn from the Operation of Proclamation dated June 12, 1907.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
