EXECUTIVE ORDER NO. 4540

CANCELLATION OF GOVERNOR'S EXECUTIVE  
ORDER NO. 4108 DATED MAY 18, 2005

WHEREAS, by Governor's Executive Order No. 4108 dated May 18, 2005, certain land situated at Waiakea, South Hilo, Island of Hawaii, Hawaii, containing an area of 0.821 acre, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for Addition to a Combined Veterans Center, Veterans Housing and Other Related Purposes, to be under the control and management of the County of Hawaii; and



WHEREAS, the Board of Land and Natural Resources at its meeting held on April 13, 2017, approved the cancellation of Governor's Executive Order No. 4108 dated May 18, 2005.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 4108 dated May 18, 2005, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

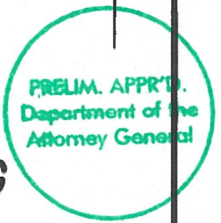
