



area of 13.458 acres covered by Transfer Certificate of Title 908339 issued to the State of Hawaii, and Lot 19888 shall have direct access to Lot 17853 and then over Easement 4770, as shown on Map 712, to Farrington Highway, a public road as set forth by Land Court Order recorded as Document No. T-10193134, SUBJECT, HOWEVER, to any and all encumbrances that may be noted on Transfer Certificate of Title 908339, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being a survey description prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated C.S.F. No. 25,649 and dated February 20, 2018, and a copy of Land Court Map 1667.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the City and County of Honolulu shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

SUBJECT, FURTHER, to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.

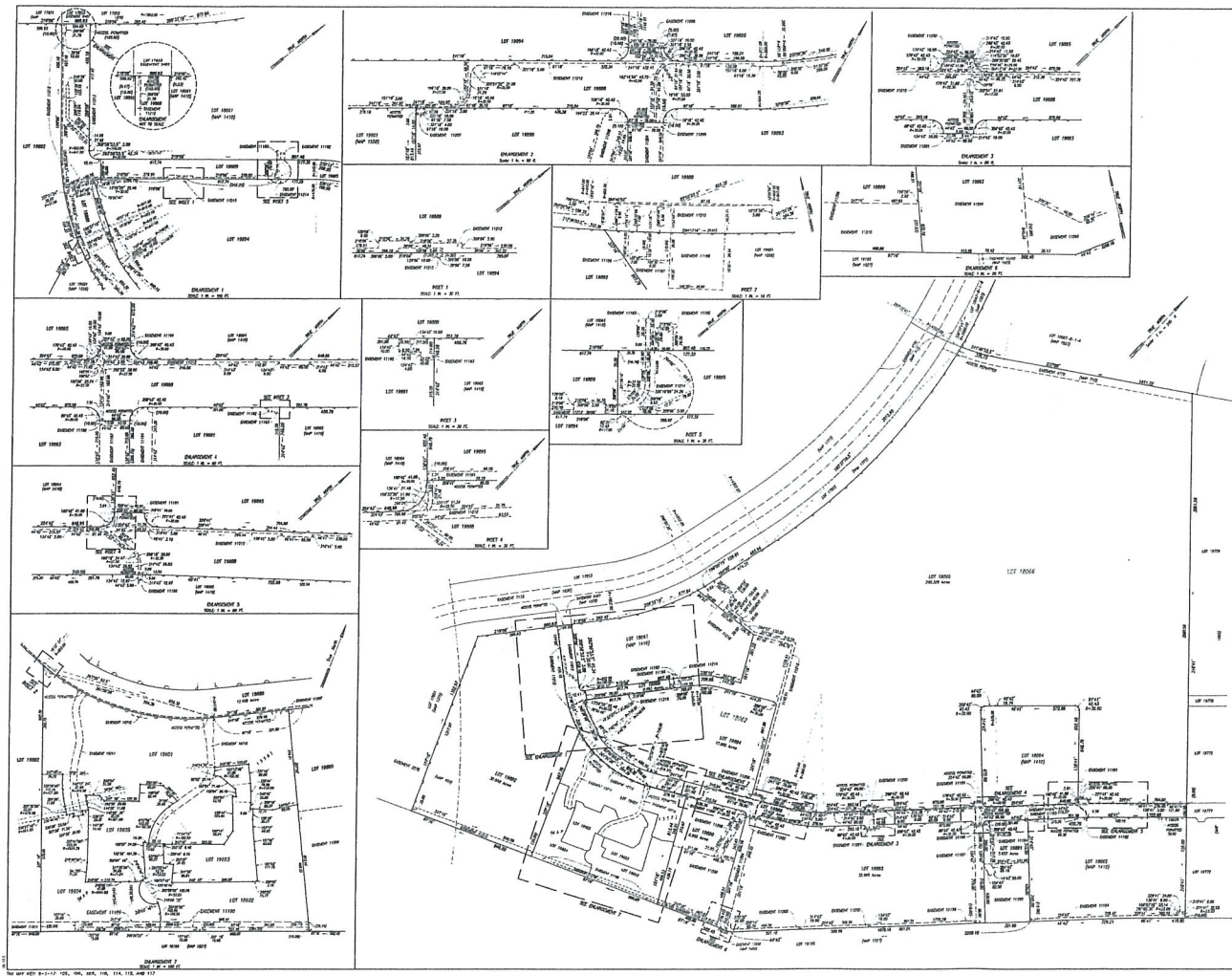
