CANCELLATION OF REMAINING PORTIONS OF GOVERNOR'S EXECUTIVE ORDER NO. 1330 DATED JUNE 16, 1949

WHEREAS, by Governor's Executive Order No. 1330 dated June 16, 1949, certain lands and improvements situate at Kalia, Waikiki, Honolulu, Hawaii, containing remainder portions consisting of Parcel 2 containing an area of 1.374 acres, Parcel 3 containing an area of 0.007 acre, and Parcel 4 containing an area of 2.472 acres, all more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, were set aside for addition to Kewalo and Ala Wai Yacht Basins, to be under the control and management of the State of Hawaii,


