CANCELLATION OF THE REMAINING PORTION OF GOVERNOR'S EXECUTIVE ORDER NO. 1786 DATED MAY 1, 1957

WHEREAS, by Governor's Executive Order No. 1786 dated May 1, 1957, certain lands and improvements situate at Waikiki, Honolulu, Oahu, Hawaii, containing remainder portion of 473.039 acres, more or less, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for Beach Control Purposes, to be under the control and management of the State of Hawaii, Department of Land and Natural Resources, Division of Boating and Ocean Recreation, as successor in interest of the Board of Harbor Commissioners; and

PRELIM. APPR'D. Department of the Attorney General WHEREAS, the Board of Land and Natural Resources at its meetings held on December 9, 2010 and May 24, 2019, approved the cancellation of the remaining portion of Governor's Executive Order 1786 dated May 1, 1957.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that the remaining portion of Governor's Executive Order 1786 dated May 1, 1957, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.


