EXECUTIVE ORDER NO.

CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 2170 DATED OCTOBER 15, 1964

WHEREAS, by Governor's Executive Order No. 2170 dated October 15, 1964, certain land and improvements situate at Kalia, Waikiki, Honolulu, Oahu, Hawaii, consisting of Lot 1-C containing an area of 18,563 square feet, as shown on Map 2 of Land Court Consolidation No. 64, Transfer Certificate of Title No. 100295 issued to the State of Hawaii, and recorded in the Office of the Assistant Registrar of the Land Court of the State of Hawaii as Document No. 346630, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was

set aside for Addition to Ala Wai Boat Harbor, to be under the control and management of the State of Hawaii, Department of Land and Natural Resources, Division of Boating and Ocean Recreation, as successor in interest of the Department of Transportation; and

WHEREAS, the Board of Land and Natural Resources at its meetings held on December 9, 2010 and May 24, 2019, approved the cancellation of Governor's Executive Order No. 2170 dated October 15, 1964.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 2170 dated October 15, 1964, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
