CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 1880 DATED FEBRUARY 20, 1959

WHEREAS, by Governor's Executive Order No. 1880 dated February 20, 1959, certain lands and improvements, situate at Kalapaki and Hanamaulu, Puna (Lihue), Kauai, Hawaii, consisting of Parcels 1-A, 1-B, 4-A, 4-B, 5-A, 5-B and 5-C, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for addition to Lihue Airport, to be under the control and management of the State of Hawaii, Department of Transportation, Airports Division, successor in interest to Hawaii Aeronautics Commission; and

WHEREAS, the Board of Land and Natural Resources at its



meetings held on March 10, 2017 and May 10, 2019, approved the cancellation of Governor's Executive Order No. 1880 dated February 20, 1959.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 1880 dated February 20, 1959, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.


