EXECUTIVE ORDER NO. 4612

CANCELLATION OF GOVERNOR'S EXECUTIVE
ORDER NO. 3259 DATED AUGUST 11, 1984

WHEREAS, by Governor's Executive Order No. 3259 dated August 11, 1984, certain land and improvements, situate at Hanamaulu, Lihue (Puna), Kauai, Hawaii, containing an area of 5.663 acres, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for Airport Purposes, to be under the control and management of the State of Hawaii, Department of Transportation, Airports Division; and



WHEREAS, the Board of Land and Natural Resources at its meetings held on March 10, 2017 and May 10, 2019, approved the cancellation of Governor's Executive Order No. 3259 dated August 11, 1984.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 3259 dated August 11, 1984, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

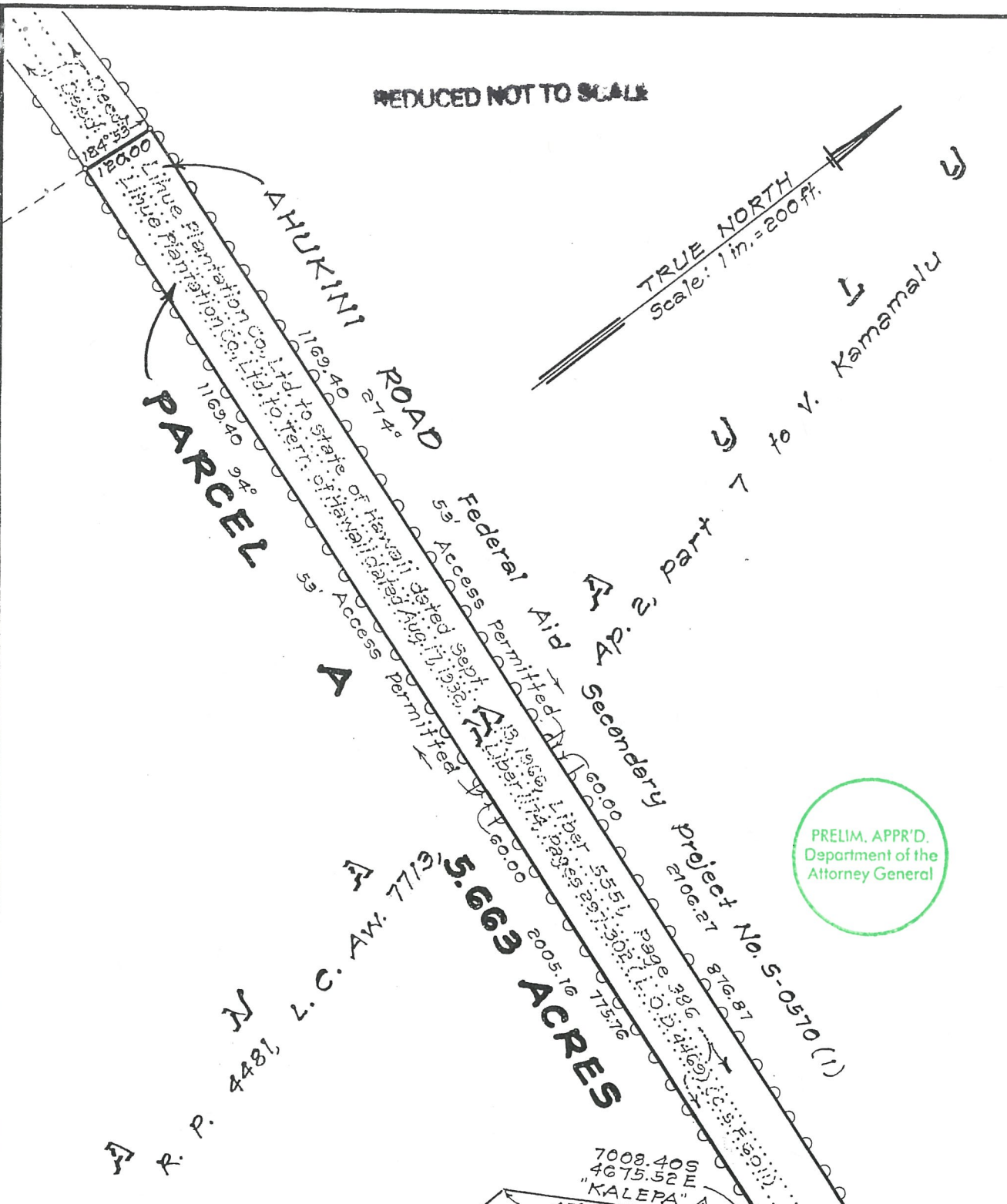
