EXECUTIVE ORDER NO. 4633

CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 1396 DATED OCTOBER 11, 1950

WHEREAS, by Governor's Executive Order No. 1396 dated October 11, 1950, certain land situate at Hauula, Koolauloa, Oahu, T.H., containing an area of 36,696 square feet, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for the Hauula Fire Station site, to be under the control and management of the Board of Supervisors of the City and County of Honolulu; and

PRELIM, APPR'D. Department of the Attorney General WHEREAS, the Board of Land and Natural Resources at its meeting held on September 27, 2019, approved the cancellation of Governor's Executive Order No. 1396 dated October 11, 1950.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 1396 dated October 11, 1950, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.


