EXECUTIVE ORDER NO. 4635

SETTING ASIDE LAND FOR PUBLIC PURPOSES

BY THIS EXECUTIVE ORDER, I, the undersigned, Governor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, as amended, and every other authority me hereunto enabling, do hereby order that the public land and improvements hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR AGRICULTURAL PURPOSES, to be under the control and management of the State of Hawaii, Department of Hawaiian Home Lands, being that parcel of land situate at Waiohinu, Kau, Island of Hawaii, Hawaii, and identified as "(Revised - July 2020)

Portion of the Government (Crown) Land of Waiohinu," containing a gross area of 429.13 acres and a net area of 378.87 acres, after excepting and excluding therefrom exclusions (50.26 acres), and

SUBJECT, HOWEVER, to Easement A-1 (30.00 feet wide) for Access Purposes, containing an area of 70,121 square feet, and Easement A-2 (30.00 feet wide) for Access Purposes, containing an area of 16,873 square feet, and

SUBJECT, ALSO, to easements for roads, trails, ditches, flumes, pipelines, utilities and other reservations and rights-of-way in favor of all entitled thereto and to the following easements:

- 1. Waiohinu Drainage Improvements Parcel 5, Perpetual Non-Exclusive Easement for Drainage Purposes covered by Grant of Easement: State of Hawaii to County of Hawaii, Department of Public Works dated July 28, 1998 and recorded as Document No. 98-122658 (L.O.D. S-28289), and
- 2. Waiohinu Drainage Improvements Parcel 16, Perpetual Non-Exclusive Easement for Drainage Purposes covered by Grant of Easement: State of Hawaii to County of Hawaii, Department of Public Works dated July 28, 1998 and recorded as Document No. 98-122658 (L.O.D. S-28289), and

RESERVING to the State of Hawaii, it successors and assigns, a perpetual easement for Government Survey Triangulation Station "HAAO", located within the above-described parcel of land, together with rights of ingress and egress to said triangulation station for observation, inspection, maintenance and repair, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 25,801 and dated July 8, 2020.

The State of Hawaii, Department of Hawaiian Home Lands, will be responsible for securing access to the subject property from the State of Hawaii, Department of Transportation, Highways Division, as well as any access that may be needed over any adjacent private lands.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever,



the State of Hawaii, Department of Hawaiian Home Lands shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

SUBJECT, FURTHER, to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.
