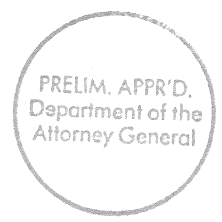

EXECUTIVE ORDER NO. 4643

CANCELLATION OF GOVERNOR'S EXECUTIVE
ORDER NO. 3488 DATED NOVEMBER 14, 1990

WHEREAS, by Governor's Executive Order No. 3488 dated November 14, 1990, certain lands situate at Kawailoa, Kailua, Koolaupoko, Oahu, Hawaii, containing an area of 122.157 acres, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for Hawaii Youth Correctional Facility, to be under the control and management of the Department of Public Safety, State of Hawaii; and



WHEREAS, the Board of Land and Natural Resources at its meeting held on July 26, 2019, approved the cancellation of Governor's Executive Order No. 3488 dated November 14, 1990.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 3488 dated November 14, 1990, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of Hawaii to be affixed. Done at the Capitol at Honolulu this 22nd day of December, 2020.



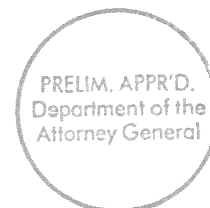

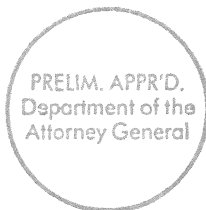

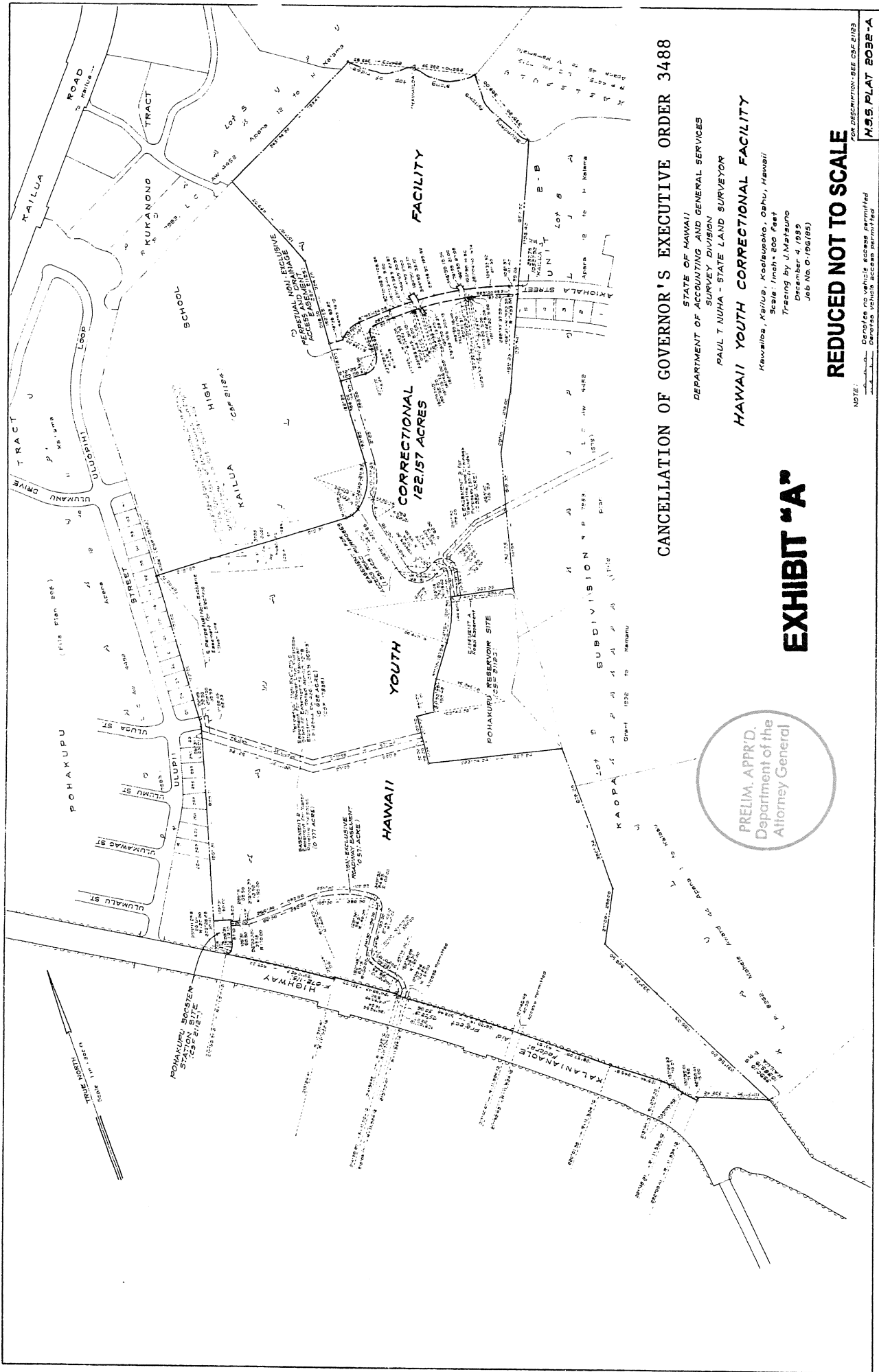
