CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 1781 DATED MARCH 12, 1957

WHEREAS, by Governor's Executive Order No. 1781 dated March 12, 1957, certain land situate at Keaau, Puna, Island of Hawaii, Hawaii, consisting of Lot A-16-B, as shown on Map 41 of Land Court Application No. 1053 (amended), filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii containing an area of 3.044 acres, covered by Transfer Certificate of Title No. 66,421 issued to the Territory of Hawaii, TOGETHER with the right of ingress and egress for all purposes including utilities over Plantation Road marked "J", as shown on said Map 41, from Volcano Road (Exclusion 8-A) to the northwest boundary of said Lot A-16-B until such time that said

right of ingress and egress for all the above-mentioned purposes can be relocated on Lot 8 as shown on Map 1 of Land Court Application No. 1689, covered by Original Certificate of Title No. 60,091 and a portion of Lot A-16-A as shown on Map 41 of said Land Court Application No. 1053 covered by said Transfer Certificate of Title No. 15,481, TOGETHER ALSO with an easement right to lay, construct and maintain a pipeline along said Lot 8, and a portion of said Lot A-16-A, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside for the Hawaii National Guard Armory Site, to be under the control and management of the Hawaii National Guard of the State of Hawaii, Department of Defense; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on May 8, 2020, approved the cancellation of Governor's Executive Order No. 1781 dated March 12, 1957.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 1781 dated March 12, 1957, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
