### SETTING ASIDE LAND FOR PUBLIC PURPOSES

BY THIS EXECUTIVE ORDER, I, the undersigned, Governor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, as amended, and every other authority me hereunto enabling, do hereby order that the public land and improvements hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR RECREATIONAL PROGRAMS AND EXPANDED COMMUNITY USE SITE, to be under the control and management of the County of Hawaii, being that parcel of land and improvements situate at Keaau, Puna, Island of Hawaii, Hawaii and identified as "Recreational Programs and Expanded Community Use Site," being all of Lot A-16-B as shown on Map 41 of Land Court Application 1053, filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii containing an area of 3.044 acres, covered by Transfer Certificate of Title No. 66421 issued to the Territory of Hawaii (Land Office Deed 14005), Together with the following:

- 1. Easement for all purposes across Plantation Road marked "J";
- 2. Easement for pipeline purposes across Lot 8 as shown on Map 1 of Land Court Application 1689; and
- 3. Easement for pipeline purposes across Lot A-16-A as shown on Map 41 of Land Court Application 1053;

SUBJECT, HOWEVER, to any and all encumbrances that may be noted on Transfer Certificate of Title No. 66421, more particularly described in Exhibit "A" and delineated on Exhibit "B," both of which are attached hereto and made parts hereof, said exhibits being respectively, a survey description prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, being designated C.S.F. No. 25,836 and dated January 22, 2021, and a copy of Land Court Map 41.

SUBJECT, HOWEVER, to the condition that upon cancellation of this executive order or in the event of non-use or abandonment of the premises or any portion thereof for a continuous period of one (1) year, or for any reason whatsoever, the County of Hawaii shall, within a reasonable time, restore the premises to a condition satisfactory and acceptable to the Department of Land and Natural Resources, State of Hawaii.

### SUBJECT, FURTHER:

- 1. to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
- 2. that the State of Hawaii, Department of Defense and the County of Hawaii have an agreement that allows the Starbase Program continued use of the improvements until another site can be found for the program.
- 3. that the County of Hawaii understands that no Phase 1 Environmental Site Assessment has been performed on the property and agrees to accept the property and improvements in

"as is, where is" condition with all faults and defects, whether latent or patent, and to be responsible for the repair and maintenance of the improvements, including areas utilized by the State of Hawaii, Department of Defense Starbase Program.

This executive order does not authorize the recipient of the set aside to sell or exchange or otherwise relinquish the State of Hawaii's title to the subject public land.
