EXECUTIVE ORDER NO. 4656

CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 1108 DATED MARCH 27, 1945

WHEREAS, by Governor's Executive Order No. 1108 dated March 27, 1945, certain land situate at Kapaa, Puna, Kauai, containing an area of 0.659 acre, excepting and reserving therefrom a right-of-way for the ditch (10 feet in width) across this lot, containing an area of 0.04 acre, leaving a net area of 0.619 acre, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, was set aside to prevent traffic hazard and on which no construction of any kind shall be made but shall be grassed and used as a park, to be under the control and management of the Board of Supervisors of the County of Kauai; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on February 28, 2020, approved the cancellation of Governor's Executive Order No. 1108 dated March 27, 1945.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 1108 dated March 27, 1945, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
