




area of 35.08 acres, more or less, after exclusion, and Parcel D containing an area of 5.01 acres, more or less, more particularly delineated on the map marked Exhibit "A" attached hereto and made a part hereof, were set aside for Potential Demonstration Forest Projects Along Hamakua Coast, to be under the control and management of the Department of Land and Natural Resources, Division of Forestry and Wildlife; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on April 8, 2016, approved the cancellation of Governor's Executive Order No. 3992 dated April 25, 2003.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11 and Section 183-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 3992 dated April 25, 2003, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.



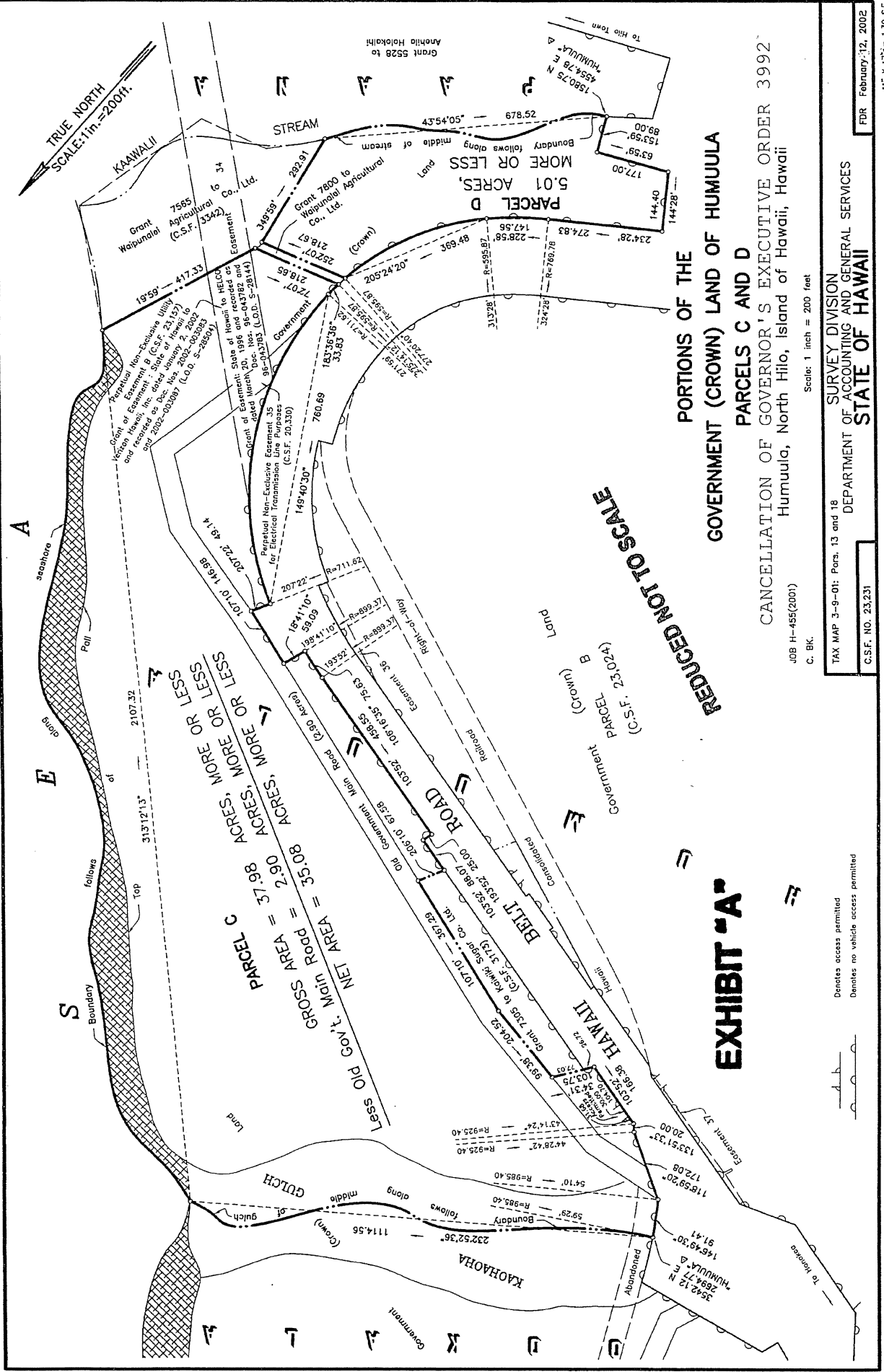
