EXECUTIVE ORDER NO. 4675

CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 3555 DATED JUNE 17, 1992

WHEREAS, by Governor's Executive Order No. 3555 dated June 17, 1992, certain parcels of land designated as Waimanu National Estuarine Research Reserve, Parcel A situate at Waimanu, Hamakua, Island of Hawaii, Hawaii, containing a gross area of 3292.00 acres, more or less and a net area of 2998.48 acres, more or less, after exclusions, and Waimanu National

Estuarine Research Reserve, Parcel B situate at Muliwai, Hamakua, Island of Hawaii, Hawaii, containing an area of 545 acres, more or less, more particularly delineated on the maps respectively marked Exhibit "A" and Exhibit "B" both attached hereto and made parts hereof, were set aside for Waimanu National Estuarine Research Reserve Purposes, to be under the control and management of the Department of Land and Natural Resources, Division of Forestry and Wildlife; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on April 8, 2016, approved the cancellation of Governor's Executive Order No. 3555 dated June 17, 1992.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11 and Section 183-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 3555 dated June 17, 1992, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.
