CANCELLATION OF GOVERNOR'S EXECUTIVE ORDER NO. 4474 DATED NOVEMBER 24, 2014

WHEREAS, by Governor's Executive Order No. 4474 dated November 24, 2014, certain lands situate at Kaena, Waialua, Oahu, Hawaii, consisting of:

"Agriculture Purposes Site, Parts 1 and 2," Part 1 being all of Lot 4 as shown on Map 3 of Land Court Application 588 filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii containing an area of 36.06 acres, covered by Transfer Certificate of Title No. 219,040 issued to the State of Hawaii, and Part 2 being all of Lot 5 as shown on Map 3 of Land Court Application 588 filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii containing an area of 29.74 acres covered by Transfer Certificate of Title No. 197,552 issued to the State of Hawaii,

"Agriculture Purposes Site, Part 3," being a portion of Lot 1-A as shown on Map 4 of Land Court Application 588 filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii, covered by Transfer Certificate of Title No. 114,447, containing an area of 5.801 acres, and

"Agriculture Purposes Site, Part 4," containing a gross area of 76.674 acres and a net area of 76.376 acres after excluding therefrom Parcel 2 of Dillingham Air Force Base Facilities, Governor's Executive Order 1530 containing an area of 0.298 acre, more particularly respectively delineated on the maps marked Exhibits "A," "B," and "C," attached hereto and made parts hereof, were set aside for agriculture purposes, to be under the control and management of the Agribusiness Development Corporation a public body corporate and politic and an instrumentality and agency of the State of Hawaii; and

WHEREAS, the Board of Land and Natural Resources at its meeting held on April 22, 2022, approved the cancellation of Governor's Executive Order No. 4474 dated November 24, 2014.

NOW, THEREFORE, I, DAVID Y. IGE, Governor of the State of Hawaii, by virtue of the authority vested in me under Section 171-11, Hawaii Revised Statutes, as amended, do hereby order that Governor's Executive Order No. 4474 dated November 24, 2014, be and the same is hereby cancelled and declared of no force and effect.

SUBJECT to disapproval by the Legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.


